



## **BECOMING A MEMBER IN THE CLUB**

### **Corporate Membership**

#### **Includes (5) Individual Memberships**

Membership in the Club is subject to approval by the Club only. Prospective Members who wish to be considered for membership must take the following steps:

- A. Fully complete and execute the Application for Membership, a copy of which is attached. Submit the **completed** and executed Application for Membership to the membership Office of the Club.
- B. Submit the initiation fee.

After receiving the Application, Management may check references, perform background investigations and interview the applicant. Management in its sole discretion will determine whether the applicant satisfies the relevant conditions of membership and whether the applicant should be invited for membership. The Club will provide written notice to the applicant of the action taken by the Club with respect to the application within 30 days of the Club's receipt of the completed application and Initiation Fee. If the application is denied, the Club will refund to the applicant any funds forwarded to the Club by the applicant, without interest or other premium.

**Management specifically reserves the right to approve or reject any membership applicant for any reason(s) which Management deems to be pertinent to the best interest of the Club.**

### **USE OF THE CLUB**

The Club will be a recreational club, primarily for the use and benefit of the members and their guests. The Club grounds & clubhouse facility will be opened to the public for charitable and other activities & uses strictly at the discretion of Management.

The Club reserves the right to designate persons to use any or all of the Club facilities, including the Road Courses, for any purpose and upon such terms and conditions as are established from time to time by the Club. The persons designated to use the Club facilities may include, without limitation, persons who are employees of the Club, persons who are prospective members of the Club, persons who are involved in special events at the Club and other persons permitted by the Management from time to time.

In-season maintenance and Club authorized private or special events may occasionally preclude membership access to, or use of the facilities. All known dates affecting membership access will be posted at the outset of each season's operating calendar and/or as far in advance as reasonably possible.
